**Interment Rights**

The following price includes the interment rights, care & maintenance fund contribution, and HST. Each individual grave may accommodate a maximum of three interments in one of the following combinations: 2 caskets and 1 cremation urn (provided the first casket is buried at extra depth), 1 casket and 2 cremation urns, 3 cremation urns. Cremation lots can accommodate a maximum of 2 cremation urns.

**Interment Fees**

The following prices include digging and backfilling the grave, removal of excess soil, reseeded and fertilizing. HST is not applicable to these prices.

**Funeral Mass or Chapel Service times after 10:30 will not be accepted. Funerals must arrive in the cemetery by 12:00.**

**Graveside cremation interments not preceded by a Funeral Mass or Chapel Service will be limited to 3 per Saturday, and must be scheduled for one of the following times: 9:00, 9:45, or 10:30.**

#### **Payment Terms**

For all At-Need purchases, payment is due in full.

Pre-Need purchases under \$5,000.00: a 40% deposit is due at time of purchase, with the balance payable quarterly for 1 year, interest free.

Pre-need purchases over \$5,000.00: a 40% deposit is due at time of purchase, with the balance payable quarterly for 2 years, interest free.

Pre-Need services purchased separately from interment rights are due in full at time of purchase.
