



COVID-19 Protocols

Updated July 15, 2021

Effective Date: July 16, 2021

The Catholic Cemeteries of the Diocese of Hamilton is committed to serving our families and working to ensure their health and safety. We are equally committed and focused on the health and safety of our employees. We are therefore adjusting our operations and levels of public interaction in an effort to do our part to slow the transmission of the virus. Please know that we are taking extra precautions to keep our facilities and offices sanitized. Our office remains open to serve you and your family. Please review the following information:

Safe Distance Protocol

The Catholic Cemeteries has implemented a Safe Distance Protocol. We ask that there be no physical contact such as handshakes or hugs, and our employees will observe a 6-foot distance with visitors wherever possible.

Screening

All visitors will be screened:

1. Do you have any of these symptoms?
 - Fever and/or chills
 - Cough or barking cough (croup)
 - Shortness of Breath
 - Sore throat
 - Difficulty swallowing
 - Decrease or loss of smell or taste
 - Runny or stuffy/congested nose
 - Headache
 - Nausea/Vomiting, diarrhea
 - Muscle aches
 - Extreme tiredness
 - Pink eye (for adults)
 - Stomach pain (for adults)
 - Falling down often (for older adults)

2. Has a doctor, health care provider or public health unit told you that you should currently be isolating (staying at home)?
3. Have you been identified as a “close contact” of someone who currently has COVID-19 in the last 14 days?
4. Have you received a COVID Alert exposure notification on your cell phone in the last 14 days (and have not been tested or waiting for your result)?
5. Have you or anyone you live with traveled outside of Canada in the last 14 days?
6. Is anyone you live with currently experiencing any new COVID-19 symptoms and/or waiting for test results after experiencing symptoms?

If a visitor answers YES to any of the above questions, PLEASE DO NOT enter this location. We ask that they kindly return home and call us to make arrangements by alternative means (phone/email, etc.).

For All Office Appointments, Cremation and Interment Services

- Any individual who is under self-isolation or does not pass the self-screening test is not permitted to attend any of our offices, cemeteries or mausoleum building for any reason.
- As of July 16, our mausoleum buildings will return to normal visitation hours. Visitors must screen themselves prior to entering the building, wear a mask or face covering (unless they are unable to do so for medical purposes), and maintain physical distancing with those outside their household.
- Our reception rooms at Holy Sepulchre Cemetery, Burlington and Marymount Cemetery, Guelph are not available for use.
- Offices are open for both pre-need and at-need arrangements by appointment only. Where feasible, arrangements may be completed by telephone or other electronic means. Walk-in visits without an appointment will not be permitted.
- Families attending a cemetery office for an in-person meeting are required to wear a mask, unless they are unable to do so for medical purposes. No more than two family members will be permitted to enter the office.

Please be reminded of our Safe Distance Protocol to which all attendees will be required to adhere and maintain a distance of at least 6 feet from employees at all times.

Interments/Entombments for non-COVID-19-related Deaths

- In keeping with the most recent directives from the Province of Ontario and the Bereavement Authority of Ontario concerning attendance at a funeral, the following will be observed:
 - Unless they are from the same household, all attendees at an outdoor graveside interment service are required to maintain a physical distance of at least 6 feet at all times.
 - For outdoor graveside services with a funeral director present, no capacity limit will be enforced.
 - The maximum number of attendees permitted to attend an outdoor graveside burial service where no funeral director is present will be limited to 25. For purposes of contact tracing, families will be required to provide a list of attendees to cemetery staff prior to the interment service.

- Immediately following the committal service, attendees must return to their vehicles. Cemetery staff will not approach until all attendees have left the immediate vicinity of the grave.
- The maximum number of attendees permitted at a committal inside a mausoleum is present is as follows:
 - Our Lady of Victory Mausoleum, Burlington: 20
 - Holy Souls Mausoleum, Burlington: 10
 - Our Lady of Peace Mausoleum, Burlington: 15
 - Our Lady of Hope Mausoleum, Ancaster: 20
 - Our Lady of the Angels Mausoleum, Stoney Creek: 20
 - Our Lady of the Assumption Mausoleum, Paris: 20
 - Our Lady Immaculate Mausoleum, Guelph: 20
- For purposes of contact tracing, families will be required to provide a list of attendees to cemetery staff prior to the interment service when no funeral director is present.
- All committal prayer services will take place in the main chapel area of the mausoleum.
- Immediately following the committal prayers, attendees must exit the mausoleum. No one will be permitted to accompany the casket to the place of entombment or witness the entombment process. Cemetery staff will not approach the casket until all attendees have left.
- Upon request, 3 family members will be allowed to view a casket or urn after it has been placed inside the crypt or niche before it is sealed.
- Families for mausoleum committals who wish to have more than the maximum allowable number of attendees inside will be given the option of holding the committal service outside the entrance of the mausoleum. Immediately following the committal service, all attendees must return to their vehicles and depart. Cemetery staff will not approach the casket until all attendees have left. Upon request, 3 family members will be allowed to enter the mausoleum to view a casket or urn after it has been placed inside the crypt or niche before it is sealed.

Interments/Entombments for COVID-19-related Deaths

- For entombment inside a mausoleum, committal services must take place outside the main doors of the mausoleum. Once the committal service is complete, the casket or urn will be left outside the entrance door. Once the family has returned to their vehicles, the cemetery staff will proceed with the entombment. For an outdoor crypt or columbarium niche, staff will complete the entombment once the family has left the vicinity of the burial space. Families will not be allowed to attend the crypt until after staff have completed the entombment and sealed the crypt.
- For in-ground burial, caskets will be placed into the concrete container (liner or vault) immediately upon arrival at the grave. All other protocols indicated above will be enforced.
- Attendance will be restricted to a maximum of 20 people, including clergy.
